Minutes of Town Board Meeting  
Tuesday, May 24, 2005  
Perry Town Hall

1. Call to order. Chairman Pat Downing called the meeting to order at 7:35 PM. Supervisors Larry Price and Roger Kittleson and Clerk Mary Price were present. Also in attendance: Kay Watson, Deputy Mike Kitts, WI DOT Dan Prues, Terry Miller, Monica Miller, Gary Boley, Joanne Kittleson, Dan Watson, Darrell Walker, Willis Volden.
2. Review petition and discuss vehicular traffic problems in Daleyville. Kay Watson presented her observations of speeding problems in the Daleyville area and steps she initiated to resolve these problems. She presented to the Town Board a petition that she initiated and circulated to Daleyville residents. The petition was signed by 54 residents. She gave a copy of the petition to Deputy Kitts and Mr. Prues for their respective agencies. Monica Miller indicated that she bought "Slow – Children" signs for her yard. Darrell Walker requested new signs and additional signs. Deputy Kitts indicated that a radar board might be available on loan from the County. Larry Price presented information that the Town Board received at a WI DOT meeting regarding Hwy. 78 improvements planned. Deputy Kitts presented options and reported that Lt. Ritter has authorized overtime for enforcement and formed new Traffic Teams, and advised citizens to obtain speeders' license plate numbers and report this information to Dane Co. Sheriff's Dept. Pat Downing requested intensive patrolling for two months. Dan Prues explained signage practices for state highways. He will check speed limit sign placement and check passing zones on Hwy 78 in and around Daleyville. He offered suggestions to accelerate the Hwy 78 improvement schedule. He will check traffic counts on Hwy 78 and CTH H. Deputy Kitts will obtain cost information for a radar board.
3. Review mutual agreement to maintain N. Perry Road with Town of Blue Mounds. The Board reviewed the draft mutual agreement. Larry Price moved and Roger Kittleson seconded a motion to approve the Mutual Agreement with Town of Blue Mounds for North Perry Rd. maintenance. Motion carried.
4. Bridge Inspection/Replacement. The Board reviewed correspondence received from Dane County Highway Dept. regarding the bridge replacement program. Roger Kittleson moved and Larry Price seconded a motion to postpone maintenance on Pleasant Valley bridge. Motion carried.
5. Closed and Open Sessions. Larry Price moved and Roger Kittleson seconded a motion to convene closed session to discuss negotiations of possible purchase of public property, and to confer with legal counsel concerning strategy under WI Stat. 19.85(1)(e) and 19.85(1)(g); Roll Call vote – Pat Downing, Yes; Roger Kittleson, Yes; Larry Price, Yes; Motion carried. Closed session convened at 10:05 PM. Larry Price moved and Roger Kittleson seconded a motion to reconvene to open session. Roll Call vote – Pat Downing, Yes; Roger Kittleson, Yes; Larry Price, Yes; Motion carried. Open session reconvened at 11:10 PM.
6. Adjournment. Roger Kittleson moved and Larry Price seconded a motion to adjourn. Motion carried. The meeting adjourned at 11:16 PM.
