Minutes of Town Caucus  
Tuesday, January 23, 2007

The electors of the Town of Perry, Dane County, Wisconsin held a Caucus at the Town Hall on Tuesday, January 23, 2007 for the purpose of nominating candidates for Town Board Chairman, Supervisor I and Supervisor II, Treasurer and Clerk.

**Call to order** – Town Chairman Pat Downing called The Caucus to order at 8:05 PM. **Election of Officials to Conduct the Caucus** – Since Pat Downing will be a candidate for nomination, a Caucus Chairman was requested. Larry Price moved and Ken Hefty seconded a motion to nominate Ed Sutter to serve as Caucus Chair. Chairman Pat Downing requested additional nominations. Ed Sutter accepted the nomination to chair the Caucus. A voice vote affirmed the nomination. Caucus Chairman Ed Sutter requested two volunteers to serve as tellers to canvass the votes cast at the caucus. Linda Bluschke and Alice Yaeger volunteered to serve as tellers. Larry Price moved and Roger Kittleson seconded the nomination to appoint Linda Bluschke and Alice Yaeger to serve as caucus tellers. A voice vote affirmed the nomination.

**Nominations** – Caucus Chairman Ed Sutter opened the nominations for Town offices.

Town Chairman

Duane Iverson moved and Richard Keller seconded the nomination of Bret Chizek for Town Chairman. Johan Hoff moved and Gary Boley seconded the nomination of Pat Downing for Town Chairman. Caucus Chairman Ed Sutter called three times for any additional nominations for Town Chairman. No further nominations were presented. Duane Iverson moved and Johan Hoff seconded a motion to close the nominations. Motion carried.

### Supervisor #1

Ken Hefty moved and Larry Price seconded the nomination of Roger Kittleson for Supervisor #1. Johan Hoff nominated Gary Boley for Supervisor #1. Gary Boley declined the nomination. Nomination failed for lack of a second. Caucus Chairman Ed Sutter called three times for any additional nominations for Supervisor #1. No further nominations were presented. Mick Klein Kennedy moved and Margaret Berg seconded a motion to close the nominations. Motion carried.

### Supervisor #2

Larry Price moved and Ken Hefty seconded the nomination of Mick Klein Kennedy for Supervisor #2. Johan Hoff nominated Kevin Kovacs for Supervisor #2. Kevin Kovacs declined the nomination. Nomination failed for lack of second. Margaret Berg nominated Gary Boley for Supervisor #2. Gary Boley declined the nomination. Nomination failed for lack of second. Caucus Chairman Ed Sutter called three times for any additional nominations for Supervisor #2. No further nominations were presented. Richard Keller moved and Michele Kittleson seconded a motion to close the nominations. Motion carried.

### Treasurer

Margaret Berg moved and Susan Kovacs seconded the nomination of Judy Keller for Treasurer. Caucus Chairman Ed Sutter called three times for any additional nominations for Treasurer. No further nominations were presented. Margaret Berg moved and Richard Keller seconded a motion to close the nominations. Motion carried.

### Clerk

Ann Windsor moved and Roger Kittleson seconded the nomination of Mary Price for Clerk. Caucus Chairman Ed Sutter called three times for any additional nominations for Clerk. No further nominations were presented. Margaret Berg moved and Johan Hoff seconded a motion to close the nominations. Motion carried.

**Comments:** Caucus Chairman Ed Sutter asked the candidates to present comments to the Electors present. Bret Chizek, Pat Downing, Roger Kittleson and Mick Klein Kennedy presented their views concerning Town business and their records of service on the Town Board. Larry Price indicated that he has served on the Town Board since 1989 and looks forward to new perspectives on Town issues from future Town Boards.

**Adjourn:** Dwayne Iverson moved and Margaret Berg seconded a motion to adjourn. Motion carried on a voice vote. The Town Caucus adjourned at 8:30 PM.
