## MINUTES OF TOWN BOARD MEETING

Saturday May 7, 2011

1. Pat Downing Called meeting to order at 9:05 AM. Attendance: Pat Downing, Roger Kittleson, Fritz Mani, and Mick Klein Kennedy
2. Inspect shop and equipment with Fritz Mani.
3. Tour the Town Roads to determine maintenance priorities.

**Motion:** Roger Kittleson moved and Mick Klein Kennedy seconded a motion to obtain road repair bids for:

### **Seal coat:**

Savannah Road (back 1/2) .79 mi.

Highview Road .36 mi.

Drammen Valley (part of starting at Renne Anderson's Drive, south to town line) 2.0 mi.

Lund .24 mi.

River Forks .43 double seal coat

Boley .40 mi.

Gilbertson Road .46mi.

Other work reviewed:

**Bridge inspections:** The road tour stopped at the Drammen Valley Bridge for inspection. Board would like Mary to get some information about Jet Crete work on the bridge for the Town Board to consider.

**2010 Town of Perry Road tour meeting minutes continued:**

**Culvert work:** The Road tour stopped to inspect the culvert at Perry Center Road and Hwy A. Fritz suggested possible work on dip in the road, no action taken.

**Motion:** Roger Kittleson moved and Mick Klein Kennedy seconded a motion to obtain bids for a ditch mower.

**Possible bidders:** Fritz to come up with a list of bidders and contact them.

**Motion carried 3-0**

**Motion:** Mick Klein Kennedy moved and Roger Kittleson seconded a motion to authorize Fritz Mani and Mary Price to put together a bill for the Town's work performed on behalf of the Cell Tower Installers, and to ask the cell tower company about the fact that Fritz mentioned ice had fallen from the cell tower in the last ice storm, and he found some inside the garage door, as garage door was open when the ice came loose from the tower. Town Board would like to verify what insurance covers the falling ice, and any personal harm or property damage that might occur due to the falling ice.

**Motion carried 3-0**

Fritz Mani informed the Town Board of an attempt by someone to steal fuel from the fuel tanks on the town garage site. The lock was cut but no fuel was taken.

**Motion:** Mick Klein Kennedy moved and Roger Kittleson seconded a motion to authorize Fritz Mani to get pricing on installation of motion light on west side of shed for fuel tank storage area.

**Motion carried 3-0**

As stated earlier, the Board and the Patrolman inspected the Town Garage and the Town's road equipment. The Board commented that the shop was in excellent condition as was the equipment. The Board commended Fritz Mani on the way he continues to maintain the organization of the shop and the way he has maintained the Town's equipment and roads.

**Repair Projects:** The Board looked at the concrete patch at the salt shed that Fritz Mani performed at the request of the DNR. Work looked complete.

**Adjourn.** Roger Kittleson moved and Mick Klein Kennedy seconded a motion to adjourn.

**Motion carried.** 3-0 The Meeting adjourned at 12:05 PM.
