\$208,000 total in pledges have been received. At the previous Perry Town Board meeting, Doug Nelson announced that town of Perry residents would save \$300,000.

3. Review Minutes

Gary Boley moved and Doug Nelson seconded a motion to approve the minutes from the March 1, 2014 meeting. Motion carried.

4. Treasurer's Report

Treasurer was not present.

5. Chairman's Report

The board of the Sons of Norway in Mt. Horeb has recommended members consider making individual contributions. The board is also considering a grant from their pooled funds.

Town is considering selling lease and/or leasing rights of the town's cell tower, Chair Doug Nelson recommended the town use any potential funds to prepay debt.

A recommendation and pledge form to donate will be included in the latest Friends of Perry Parks newsletter.

The town made \$32,000 extra principal payment in March. Town anticipates an additional \$20,000 for prepayment in September.
