- Announcements. Open Book session will be held on Monday, July 10, 2017 beginning at 5:00PM and ending at 7:00PM at the Town Hall. Spotted Cow Bike Tour will travel through the Town on June 25, 2017.
- 3. Comments by Town residents non-agenda items. None presented.
- 4. Dane Co. Sheriff's Deputy Christopher Moore, Community Officer presented 2016 call statistics, DaneCom update, and answered question.
- Treasurer's Report. Treasurer Stephanie Zwettler presented the monthly report recycling grant, building inspection fees, Premier Co-op dividend, and tire recycling fees were received.
- 6. Land Use: a. Building Inspector WI Dept. of Safety authorization. Ken Hefty moved and Mick Klein Kennedy seconded a motion to authorize Todd Parkos to act on the Town's behalf to implement WI Act 211. Motion carried.
