

Town of Perry
Minutes of Annual Meeting of the Electors
Perry Town Hall
Tuesday, November 10, 2020
7:30 PM, following 2021 Budget Hearing

1. Call to order. Chairman Roger Kittleson called the meeting to order at 7:50PM, following the 2021 Budget Hearing. Supervisors Ken Hefty and Mick Klein Kennedy, Treasurer – Deputy Clerk Stephanie Zwettler and Clerk Mary Price were present. Also in attendance: Mark Eastman, Mary Ann Nelson, Larry Price, Doug King and Margie King via teleconference.
2. Minutes of the Prior Annual Meeting – April 16, 2019. Mick Klein Kennedy moved and Ken Hefty seconded a motion to approve the minutes of the Town's 2019 Annual Meeting as presented. Motion carried on voice vote.
3. Review Financial Report for the year ending Dec. 31, 2019. Clerk Mary Price presented the 2019 financial report with explanations.
4. Salt and sand billing - develop proposed billing policy. Supervisor Ken Hefty and Road Patrolman Mark Eastman reported the current policy to deliver salt and sand to Town residents and billing process. Suggestions to secure the Town's salt and sand supply, notifications for commercial users and other information will be developed and posted on the Town's salt shed and website.
5. Annual Reports – Committees, special projects, updates, etc. Mary Ann Nelson presented Senior Outreach information – 14 meals per day are delivered to Town residents currently; care clinics are available; the Town's 2021 contract increased slightly to \$3601.00.
Doug King, Parks and Open Space Committee chair reminded Town residents and others that information can be found on the Town's website and from the Clerk and the Committee on the activities and projects.
6. Friends of the Parks of Perry – Heritage Circle presentation. Friends of the Parks of Perry President Mick Klein Kennedy reported the Friends' letter requesting donations and explaining the Heritage Circle presentation will be mailed in May or June, 2021.

7. Establish the compensation of elective town offices pursuant to Section 60.32(1)(a) of Wis. Statutes. Clerk Mary Price reported the current salaries paid to elected Town officials.
Mark Eastman moved and Larry Price seconded a motion to compensate the Town Chairman - \$3,200.00 per year and Supervisors - \$2,600.00 per year, beginning April 20, 2021. Motion carried on voice vote.
Ken Hefty moved and Mick Klein Kennedy seconded a motion to compensate the Clerk - \$26,000.00 per year and the Treasurer - \$13,000.00 per year, beginning April 20, 2021. Motion carried on voice vote.
8. Adopt the 2020 Town tax levy, to be paid in 2021 pursuant to WI §60.10(1)(a) - General Municipal Allowable Levy as determined by the WI Dept. of Revenue. Doug King moved and Marjorie King seconded a motion to adopt the 2020 Town tax levy, to be paid in 2021 pursuant to WI § 60.10(1)(a) - \$ 385,000.00. Yes – 10; No – 0; Abstain – 0. Motion carried.
9. Any other business lawfully presented per WI § 60.11. None presented.
10. Adjourn. Mark Eastman moved and Doug King seconded a motion to adjourn. Motion carried. The meeting adjourned at 9:00 PM.
