 Minutes of Town Board Meeting  
 Wednesday, April 6, 2022  
 Town Garage and Town Hall

1. Call to order. Chairman Roger Kittleson called the meeting to order at 8:30AM at the Town Garage. Supervisors Ken Hefty and Mick Klein Kennedy and Road Patrolman Mark Eastman were present.
