5. Ratify Town Board actions since last Committee meeting.
 - a. Update Historic District Park brochure with: 2nd highest park in Dane County; binocular icon for observation points; telescope icon for astronomy with permission; snowshoeing & skiing; kite flying; Dane Co. Historical/Cultural site logo; Groundswell Conservancy protected lands logo; "Historic Site closed in Winter;" change the word "it's" referring to the cemetery to "church's" cemetery; strike the words "be sure to visit the beautiful 1852 Hauge Log Church Historic Site" and replace with "be sure to visit the beautiful Observation Point."
 - b. Add graphics to Historic District Park Informational Markers: "Recommended by Trip Advisor; Wisconsin Department of Tourism; Travel Wisconsin; Madison Magazine."
 - c. Apply to Historic Preservation Commission for park restroom Certificate of Appropriateness.
 - d. Prepare appeal of the denial of Certificate of Appropriateness application for restroom.
 - e. Request Hauge Log Church Preservation Association to provide pedestrian passageway.
 - f. Amend Parks and Open Space Plan to allow for temporary shade tents, umbrellas, and portable toilets during special events in the Historic District Park.
 - g. Apply to DNR Knowles-Nelson Stewardship Fund for Historic District park restroom grant.
 - h. Apply to Dane County Environmental Council for Historic District Park restroom grant.
 - i. Amend Dark Sky Outdoor Lighting Ordinance.
 - j. Remove brush and tree branches obscuring view of Blue Mounds N fence line of Historic Site.
 - k. Request, prepare and sign a permanent Conservation Easement agreement with the Wisconsin Groundswell Conservancy to protect the Historic District Park in perpetuity.
 - l. Amend "Section 1.01 Purpose of the Town of Perry Building Ordinance" to say: "This Ordinance is...."designed to enforce the goals and policies set forth in the Town of Perry Land Use Plan"... add the words: "the Historic Preservation Ordinance, and in the Historic District, the Historic Preservation Plan and the Groundswell Conservancy Conservation Easement."
 - m. Amend Town of Perry Comprehensive Plan to include the goal of protecting the scenic view of the Blue Mounds from the Hauge Log Church Historic Site.
6. Co-locate Conservation Easement sign and Restroom arrow with approved Handicapped sign.
7. Co-locate Dane County Historical/Cultural Site sign with approved Parking Area sign.
8. Electronic surveillance in Historic District Park.
9. Construct new Leopold benches for Historic District Park as a school project.
10. Any other business properly presented by committee members.
11. Public comments by town residents and invited guests time permitting.
12. Schedule next meeting.
