

Town of Perry
Minutes of Town Caucus
January 17, 2023

The electors of the Town of Perry, Dane County, Wisconsin held a Caucus at the Town Hall on January 17, 2023 for the purpose of nominating candidates for Town Board Chairman, Supervisors, Treasurer and Clerk.

1. Call to order – Town Chairman Roger Kittleson called the Caucus to order at 7:00 PM. Clerk Mary Price was present. Also in attendance: Supervisor Ken Hefty, Supervisor Mick Klein Kennedy, Treasurer/Deputy Clerk Stephanie Zwettler, Road Patrolman Mark Eastman, Michele Kittleson, Janet Eastman, Larry Price *and* via teleconference: Doug King and Marjorie King.
2. Chairman Roger Kittleson led the Pledge of Allegiance.
3. Caucus Chair. Since Chairman Roger Kittleson will be a candidate for nomination, a Caucus Chairman was requested.
Larry Price moved and Michele Kittleson seconded a motion to nominate Mark Eastman to serve as Caucus Chair.
Chairman Roger Kittleson requested additional nominations to serve as Caucus Chair. [No further nominations were presented.]
Mark Eastman accepted the nomination to chair the Caucus. A voice vote affirmed the nomination. Motion carried.
4. Nominations. Caucus Chairman Mark Eastman opened the nominations for Town offices.

Town Chairman

Mick Klein Kennedy moved and Jan Eastman seconded the nomination of Roger Kittleson for Town Chairman.

The Caucus Chairman called three times for any additional nominations for Town Chairman. [No further nominations were presented.]

The Caucus Chairman announced that nominations for Town Chairman were closed.

Voice vote – Yes, 11. No, 0. Abstain, 0.

The Caucus Chairman announced the name of the nominee for Town Chairman – Roger Kittleson.

Supervisor 1

Jan Eastman moved and Larry Price seconded the nomination of Ken Hefty for Supervisor 1.

The Caucus Chairman called three times for any additional nominations for Supervisor 1. [No further nominations were presented.]

The Caucus Chairman announced that nominations for Supervisor 1 were closed.

Voice vote – Yes, 11. No, 0. Abstain, 0.

The Caucus Chairman announced the name of the nominee for Supervisor 1 – Ken Hefty.

Supervisor 2

Michele Kittleson moved and Ken Hefty seconded the nomination of Mick Klein Kennedy for Supervisor 2.

The Caucus Chairman called three times for any additional nominations for Supervisor 2. [No further nominations were presented.]

The Caucus Chairman announced that nominations for Supervisor 2 were closed.

Voice vote – Yes, 11. No, 0. Abstain, 0.

The Caucus Chairman announced the name of the nominee for Supervisor 2 – Mick Klein Kennedy

Treasurer

Jan Eastman moved and Roger Kittleson seconded the nomination of Stephanie Zwettler for Treasurer.

The Caucus Chairman called three times for any additional nominations for Treasurer. [No further nominations were presented.]

The Caucus Chairman announced that nominations for Treasurer were closed.

Voice vote – Yes, 11. No, 0. Abstain, 0.

The Caucus Chairman announced the name of the nominee for Town Treasurer - Stephanie Zwettler.

Clerk

Stephanie Zwettler moved and Michele Kittleson seconded the nomination of Mary Price for Clerk.

The Caucus Chairman called three times for any additional nominations for Clerk. [No further nominations were presented.]

The Caucus Chairman announced that nominations for Clerk were closed.

Voice vote – Yes, 11. No, 0. Abstain, 0.

The Caucus Chairman announced the name of the nominee for Town Clerk – Mary Price.

The Caucus Chairman announced that Clerk Mary Price can provide notification and WEC forms to the candidates after the caucus adjourns.

5. Adjourn: Jan Eastman moved and Doug King seconded a motion to adjourn. Motion carried on a voice vote. The Town Caucus adjourned at 7:05 PM.
